

Sir,

With reference to the subject cited above, I like to inform you that in order to implement the clause 4(c) of the Govt. O.M. dated 17-07-2004 altogether 67 vacant posts of lecturers lying in different colleges were identified for withdrawal and the same were approved by the Govt. of Assam, Education (Higher) Department, vide letter No.AHE.148/2005/84, dated 04-10-2005 with the concurrence of Finance (SIU) Department, vide U/O No.FSI.160/2005, dated 23-09-2005. But, the withdrawal posts were not utilized as there were some court cases regarding seniority of the non-sanctioned teachers.

Now, the Hon'ble High Court passed an order dated 30-06-2010 in Cont. (c) No.56/2010 to complete the whole process of regularization within a period of three months from today i.e. 30-06-2010.


In this regards you are aware about it that the following vacant posts of your college are already withdrawn and same was also informed vide this letter under reference.




